# STATEMENT OF NECESSITY

Benton McDonough, Assistant General Counsel read the following statement:

Good Morning - Members of the Council –T.C.A. 8-44-108(b)(2) states, "If a physical quorum is not present at the location of a meeting of a governing body, then in order for a quorum of members to participate by electronic or other means of communication, the governing body must make a determination that a necessity exists. Such determination, and a recitation of the facts and circumstances on which it was based, must be included in the minutes of the meeting." Furthermore, T.C.A. 8-44-108(a)(3) defines a necessity as, "matters to be considered by the governing body at the meeting require timely action by the body, that physical presence by a quorum of the members is not practical within the period of time requiring action, and that participation by a quorum of the members by electronic or other means of communication is necessary."

- The rulemaking process as it relates to the Private Probation Services Council and the military applicant procedure adopted by the legislature; and
