MINUTES

The Tennessee Real Estate Commission held a meeting April 11, 2018 at 8:30 a.m. CST in Room 1A of the Davy Crockett Tower located at 500 James Robertson Parkway Nashville, TN 37243. The Meeting was called to order by Chairman John Griess.

Chairman John Griess welcomed everyone to the Board meeting.

Executive Director Caitlin Maxwell read the public disclaimer and called roll. The following Commission Members were present: Chairman John Griess, Commissioner Diane Hills, Commissioner Fontaine Taylor, Commissioner Marcia Franks, Commissioner Bobby Wood, Commissioner Gary Blume, and Commissioner Rick Douglass. Commissioner Johnny Horne was absent. Commissioner Austin McMullen arrived during the legal report. Quorum Confirmed. Others present: Chief Counsel Denard Mickens, Assistant General Counsel Sarah Mathews, Assistant General Counsel Erica Smith, Assistant General Counsel Robyn Ryan, Assistant General Counsel Kelsey J. Bridges, paralegal Amanda Dean, Executive Director Caitlin Maxwell, and Education Director Ross White.

The April 11, 2018 board meeting agenda was submitted for approval.

Motion to approve the agenda as amended was made by Commissioner Franks and seconded by Commissioner Hills. Motion passed unanimously.

Executive Director Caitlin Maxwell, on the behalf of James Bennett, presented before the commission, the request for waiver of penalty fees for late renewal and license reinstatement due to medical issues.

COMMISSION DISSCUSSIONS

Principal Broker Failure to Supervise Complaints

Chairman Griess discussed the topic of the automatic opening o principal broker supervision complaints and asked the Commission whether they would like to continue automatically opening principal broker supervision complaints for failure to supervise. Executive Director Caitlin Maxwell presented to the Commission the numbers for principal broker supervision complaints.

The motion was made by Commissioner Blume to no longer automatically open principal broker failure to supervise complaints effective 5/1/18, this motion was seconded by Commissioner Hills. The motion passed 7-1 with Commissioner Taylor voting against.

ARELLO Conference

Commissioner Franks updated the Commission on the topics discussed at the ARELLO mid-year meeting and the various issues facing each state.

Education Recovery Account

Assistant Commissioner Carter Lawrence proposed discontinuing funding to the education recovery account. He stated the recovery fund continues to grow in excess. He discussed using the education recovery account consistent with the rule and statute for education purposes. He stated a plan would be presented at the next meeting. Motion to eliminate the continued funding by initial licensees, education providers, and education instructors to the education recovery fund was made by Commissioner Taylor and seconded by Commissioner Franks. Motion passed unanimously.
