# NEWS AND UPDATES

#### ATTORNEY GENERAL LLC OPINION

The Commission staff often receives the question: "Who is required to be licensed?" When we receive this question, we refer back to the definition of a broker and the Broker Act. Within the Act, there are exemptions for owners, attorneys in fact, and the officers of a corporation. But what about limited liability companies ("LLCs")? On September 16, 2019, the Department requested an updated opinion on this question from the Office of the Attorney General. The last opinion was given in 2014. In short, LLCs do not qualify for the corporation exemption. #### EDUCATION INSTRUCTORS

At the September meeting, the Commission requested a clarification be distributed to education instructors that are also licensed as affiliates or brokers. Instructors teaching a course may not receive continued education credit for the course that they are teaching. This statement does not apply to the students that are enrolled in the course. All continued education ("CE") where a provider/instructor has listed their name on a submitted education roster will be immediately removed and disqualified. Any individual in violation may be subject to disciplinary action.

#### **E&O PENALTY INCREASES**

We are now well over the one hundred twenty (120) day mark for licensees who failed to renew their errors and omissions ("E&O") insurance in January of 2019. This means that the fee for E&O insurance has increased. Please see law below. Once a licensee is suspended due to E&O insurance for over a year, that license is automatically revoked.

# TENN. CODE ANN. § 62-13-112. ERRORS AND OMISSIONS INSURANCE

(k)(B) For a license suspended for more than one hundred twenty (120) days but less than one (1) year, a penalty fee of five hundred dollars (\$500), plus an additional penalty fee of not more than one hundred dollars (\$100) per month for months six through twelve (6-12).

(l) (1) A license suspended more than one (1) year pursuant to this section shall be automatically revoked without any further action by the commission.

#### UPDATED FINGERPRINT INSTRUCTIONS

For any new agents, there is a revised finger print instruction form. The TBI and the vendor for fingerprints, IndentoGo, have updated their systems to give real estate agents a specific code. This should prevent errors of your fingerprints being set up for another program such as armed guards, real estate appraisers, etc. The new form can be found here: https://www.tn.gov/ content/dam/tn/commerce/documents/regboards/trec/forms/Fingerprint-Instructions.pdf

#### LOW INCOME FEE WAIVER

If you have anyone joining your firm who currently receives state or federal public assistance such as Temporary Assistance for Needy Families (TANF), Medicaid, Supplemental Nutrition Assistance Program (SNAP), or other state or federal public assistance determined to qualify by the Commissioner ("Qualifying Program"), they may be eligible to receive a waiver of initial state licensure fees. This waiver of state licensure fees applies to applicants for initial individual licenses or business licenses where the owner-applicant qualifies for the fee waiver. Please be advised that this waiver applies to fees imposed by the state only, and you may be responsible for federal licensure fees, if applicable. For more information, you can review Tenn. #### FEE REDUCTIONS

Effective November 3, 2019, the Tennessee Real Estate Commission ("the Commission") has reduced fees for initial licensure and renewals as well as eliminated certain fees. All other requirements remain the same. A breakdown of the fee changes are below:

#### PRINCIPAL BROKERS: INFORMATION FOR YOUR FUTURE LICENSEES

Military Exemption: Armed forces personnel and their spouses may be exempt from licensure. The Commission and the Department's Division of Regulatory Boards will offer an exemption from licensure, certification or permit for any person who is stationed in Tennessee as an active member of the United States Armed Forces, Reserves, or Tennessee National Guard unit, or their spouses. To qualify for exemption, the eligible person must:

- 1. Hold a valid license in the regulated profession issued by another state with reasonably similar standards for licensure. The valid license must be in good standing.
- 2. Agree to subject themselves to the jurisdiction of the Division with respect to harms or violations of the laws and rules; and
- 3. Register with the Division.

#### STAY UP TO DATE

It is important to remind your agents and fellow peers to keep their information with the Commission current. We see this issue most frequently when we have agents request to reinstate their licenses. Licensees submit the request and Commission staff works to process the request, but we do not have a current email or phone number to contact. This also happens with notices for renewal, E&O, and complaints.
