RESOLUTION

A RESOLUTION TO AMEND THE GIBSON COUNTY REGIONAL ZONING RESOLUTION TO ADOPT NEW REGULATIONS FOR WIND ENERGY SYSTEMS.

WHEREAS, pursuant to Tennessee Code Annotated Sections 13-7-101 through 13-7-117, Gibson County has adopted zoning; and,

WHEREAS, the Gibson County Regional Planning Commission has recommended an amendment to the Gibson County Zoning Resolution; and,

WHEREAS, pursuant to Tennessee Code Annotated Section 13-7-105, a public hearing was held by the Gibson County Commission on \_\_\_\_\_, the day of \_\_\_\_\_, 2016, the time and place of which was published with 15 days' advance notice;

NOW, THEREFORE, BE IT RESOLVED BY THE GIBSON COUNTY COMMISSION:

SECTION 1. That the following language be added as Section 11.815 to the Gibson County Zoning Resolution:

Section 11.815 Wind Energy Installation

A. In any zoning district, a permit may be granted upon site plan approval by the Planning Commission to allow wind energy conversion system, including such devices as wind charger, windmill, or wind turbine; subject to the following condition:

1. The distance from any tower support base to any tower support base of another wind energy device under other ownership shall be a minimum of five (5) rotor diameter distances figured by the size of the largest rotor.
2. The wind energy system operation shall not cause interference to the radio, television, or internet reception on any adjoining property.
3. To limit climbing access to the tower, a fence six (6) feet high with a locking portal shall be placed around the tower base or the tower climbing apparatus shall be limited to no more than twelve (12) feet from the ground, or the tower may be mounted on a roof top.
4. The setback distances from all lot lines to any tower support base shall be determined according to the following setback table:

B. SETBACK TABLE

Rotor Diameter	Setback Distance	Minimum Lot Area
5 feet	100 feet	1 Acre
10 feet	165 feet	2.5 Acres
15 feet	220 feet	4.5 Acres
20 feet	270 feet	6.75 Acres
25 feet	310 feet	9.0 Acres
30 feet	340 feet	10.75 Acres
35 feet or larger	365 feet	12.25 Acres

\*Where there are several towers under single ownership the minimum lot areas may be adjusted down provided the minimum setback distances are met on all perimeter units. In addition, the landing areas for all internal towers and rotors shall be within the property owned or leased by the operator.

C. Data pertaining to the machine's turbine safety and stability shall be filed with the application. Such data shall include turbine safety and acceptance results from tests conducted by a qualified individual or organization based upon standards set by the U.S. Department of Energy (DOE), Electric Power Research Institute (EPRI) Utility Wind Turbine Verification Program. U.S. Department of Energy – EPRI Wind Turbine Verification Program Electric Power Research Institute – 3412 Hillview Avenue, Palo Alto, California 94304

D. The application shall provide covenants, easements, or similar documentation from the abutting owners providing access to wind sufficient for its adequate operation, unless adequate accessibility to the wind is provided on the site.

E. Prior to approval of any wind energy system or wind turbine, evidence of financial security shall be accompanied by an estimate of the total cost of decommissioning and an estimate of the salvage value of the equipment prepared by a professional engineer licensed in the State of Tennessee. The amount of the evidence of financial security shall be one hundred twenty-five percent (125%) of the estimate of the total cost of decommissioning, minus the salvage value of the equipment, which shall be submitted to the Planning Commission by the fifth year after reaching the commercial generation date and thereafter upon request by the Planning Commission.

SECTION 2. BE IT FURTHER RESOLVED that this Resolution shall become effective immediately upon its adoption, THE PUBLIC WELFARE REQUIRING IT.

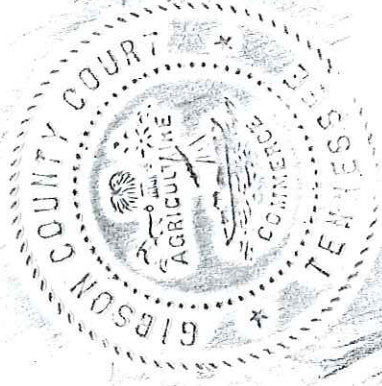
