APPLIED BEHAVIOR ANALYST LICENSING COMMITTEE

Violation: All licensees shall comply with their respective certifying entity's Guidelines for Responsible Conduct and Professional Disciplinary and Ethical Standards; Other grounds for forfeiture or nonrenewal of a license issued in accordance with this part include: ... (2) Gross or repeated negligence, incompetence, misconduct, or malpractice in professional work including, but not limited to: ... (C) Abandonment of a service recipient resulting in the termination of imminently needed care without adequate notice or provision for transition; Applicants and licensees shall notify the committee of the following within thirty (30) days of their occurrence: (1) A change of name, address, or other vital information; (2) The filing of any criminal charge or civil action against the applicant or licensee; (3) The initiation of any disciplinary charges, investigations, or findings or sanctions by a health care organization, federal or state agency, or other professional association against the licensee; and (4) Any other change in information provided by the applicant or licensee to the committee; (1) The Committee adopts, as if fully set out herein and to the extent that it does not conflict with state law, rules or Committee Position Statements, as its ethical standards the B.A.C.B.'s Ethical Code. (2) In the case of a conflict, the state law rules or position statements shall govern. Violation of the Committee's Ethical Code shall be grounds for disciplinary action pursuant to T.C.A. § 63-11-310(a); Behavior analysts are accountable for their actions and professional services and follow through on work commitments. When errors occur or commitments cannot be met, behavior analysts take all appropriate actions to directly address them, first in the best interest of clients, and then in the best interest of relevant parties; Behavior analysts maintain awareness that their personal biases or challenges (e.g., mental or physical health conditions; legal, financial, marital/relationship challenges) may interfere with the effectiveness of their professional work. Behavior analysts take appropriate steps to resolve interference, ensure that their professional work is not compromised, and document all actions taken in this circumstance and the eventual outcomes; Behavior analysts act in the best interests of the client to avoid interruption or disruption of services. They make appropriate and timely efforts to facilitate the continuation of behavioral services in the event of planned interruptions (e.g., relocation, temporary leave of absence) and unplanned interruptions (e.g., illness, funding disruption, parent request, emergencies). They

ensure that service agreements or contracts include a general plan of action for service interruptions. When a service interruption occurs, they communicate to all relevant parties the steps being taken to facilitate continuity of services. Behavior analysts document all actions taken in this circumstance and the eventual outcomes; Behavior analysts include the circumstances for discontinuing services in their service agreement. They consider discontinuing services when: (1) the client has met all behavior-change goals, (2) the client is not benefiting from the service, (3) the behavior analyst and/or their supervisees or trainees are exposed to potentially harmful conditions that cannot be reasonably resolved, (4) the client and/or relevant stakeholder requests discontinuation, (5) the relevant stakeholders are not complying with the behavior-change intervention despite appropriate efforts to address barriers, or (6) services are no longer funded. Behavior analysts provide the client and/or relevant stakeholders with a written plan for discontinuing services, document acknowledgment of the plan, review the plan throughout the discharge process, and document all steps taken; Behavior analysts include in their service agreement the circumstances for transitioning the client to another behavior analyst within or outside of their organization. They make appropriate efforts to effectively manage transitions; provide a written plan that includes target dates, transition activities, and responsible parties; and review the plan throughout the transition. When relevant, they take appropriate steps to minimize disruptions to services during the transition by collaborating with relevant service providers.

Action: Respondent's license was placed on probation for one (1) year. She must develop and implement an internal policy for appropriately transferring clients, include language explaining her termination policy in her intake packet, maintain good and lawful conduct, complete two (2) continuing education units regarding ethics, pay civil penalties totaling five hundred dollars (\$500.00), and pay costs not exceeding six thousand dollars (\$6,000.00).
