BOARD OF EMERGENCY MEDICAL SERVICES

Licensee: William Allen Angel Jr, Paramedic, Lic. No. 36779, Pikeville
Violation: Violation or attempted violation or assisting in or abetting the violation of or conspiring to violate any of the following: Any criminal statute of any state or Canadian province, or of the United States or Canada which involves moral turpitude or reflects upon the person's ability to fulfill such person's responsibilities under this part.

Action: Revocation

Violation: Violation or attempted violation or assisting in or abetting the violation of or conspiring to violate any of the following: Any criminal statute of any state or Canadian province, or of the United States or Canada which involves moral turpitude or reflects upon the person's ability to fulfill such person's responsibilities under this part.

Action: Probation until September 16, 2024; must enroll and complete a four (4) hour anger management course, as approved by the department within six (6) months of the ratification of this Order.

BOARD OF MEDICAL EXAMINERS

Licensee: Kimberly E. Reneau (Locasto), AMDX, Lic. No 5379, Maryville
Violation: Unable to practice safely by reason of Alcohol or other substances
Action: License summarily suspended

DIVISION OF PAIN MANAGEMENT CLINICS

Licensee: Southern Pain Institute, Lic. 746, Murfreesboro
Violation: Deficiencies in medical records; failure to timely cosign medical records; providing pain management treatment by telemedicine

Action: Licensed placed on probation for at least 6 months. Clinic will be reinspected within 6 months. Clinic may not petition to terminate probation unless the reinspection is approved.

Licensee: Wellness First Pain Management

Violation: Deficiencies in medical records; failure to timely cosign medical records.

Action: License probation extended until at least the 2024 license renewal. Clinic will be reinspected within 6 months. Clinic may not petition to terminate probation unless the reinspection and 2024 biennial inspection are approved.

BOARD OF PSYCHOLOGY EXAMINERS

Licensee: John Thomas Hummer, Ph.D., Lic No 3296, Jonesborough

Violation: Gross health care liability or a pattern of continued or repeated health care liability, ignorance, negligence or incompetence in the course of practice; violation of the duty to create and maintain patient records; practice outside the scope of psychological practice; engaging in practice when mentally or physically unable to safely do so; unprofessional, dishonorable, or unethical conduct.

Action: Respondent voluntarily surrendered his license, which has the same effect as revocation, and was ordered to pay costs.

Licensee: Judiann Jones, Ph.D., Lic No 3360, Memphis

Violation: Habitual intoxication or personal misuse of any drugs or the use of intoxicating liquors, narcotics, controlled substances, controlled substance analogues or other drugs or stimulants in such a manner as to adversely affect the person's ability to practice the person's profession.

Action: License was placed on probation for a minimum of two years. Respondent was assessed \$3,000 in civil penalties and ordered to pay costs.

Violation: Conviction of a felony or any offense under state or federal drug laws or conviction of any offense involving moral turpitude.

Action: License reprimand; assessed a civil penalty of \$250.00

Violation: Failed to properly maintain sufficient continuing education credits

Action: Agreed Citation; submit documented proof of the completed nine continuing education hours within 90 days; assessed civil penalty of \$450.00

Violation: Practiced on a lapsed license.

Action: Agreed Citation; assessed civil penalty of two hundred and twenty-five dollars (\$225).
