Violation: Violated October 2, 2019 consent while on probation; failed to conduct all required

fire drills or provide documentation of fire drills for years 2021 or 2022; failed to maintain functional electrically operated smoke detectors; failed to maintain adequate fire extinguishers; failed to maintain all safety equipment including an operation fire alarm control panel and properly placed exit signs; failed to report disruption of the fire alarm control panel to the Tennessee Department of Health; failed to provide documentation of an administrator who was licensed or certified; failed to maintain a written up-to-date log of all current residents in the event of an emergency; failed to have a written admission agreement, which included a procedure for handling the transfer or discharge of residents and that did not violate the residents' rights under the law; failed to have systems in place to ensure residents were taking their medication as prescribed; failed to provide timely and adequate meals to the residents; failed to maintain a clean and sanitary kitchen; failed to maintain a suitable environment; failed to maintain proper

resident files and medical records for all residents.

Action: License Summarily Suspended; Respondent shall not accept new residents:

Respondent shall relocate each resident by August 15, 2022; Respondent shall grant access to the facility to the required parties; Respondent shall provide the contact information of the individual who will hold daily calls; Respondent shall have a monitor, approved by HFC, in the facility and remaining until all residents are safely transferred and monitor costs shall be billed to the Respondent; Respondent shall submit a final report to the Board administrative staff detailing

the safe placement of all residents.
