CALL TO ORDER:

The meeting was called to order at 9:00 a.m. by Mr. Chinn with the following members present: Sweitzer, Pinkney, Wannier, Brown, Grandy, Jerman and Chinn. A quorum was established with seven members present.

DIRECTOR'S ANNOUNCEMENTS

The January 24, 2024, meeting will be held at the Davy Crockett Tower, Hearing Rm. 1A, Nashville, TN.

APPROVAL OF MINUTES

Mr. Chinn presented the October 25, 2023, minutes for approval.

Mr. Pinkney moved for approval with Mr. Jerman providing the second.

The motion CARRIED [7-0-0] unanimously by voice vote. APPROVED.

CERTIFICATE OF NEED APPLICATIONS

PC 557 eliminated TCA § 68-11-1616, which had provided that "each decision rendered by the Health Facilities Commission shall include written documentation and explanation of the factual and legal basis upon which the commission grants or denies the Certificate of Need." PC 557 only requires this for applications that are denied.

Therefore, for applications filed on or after the effective date of the relevant portions of PC $_{557}$ ($_{10/1/2021}$), a simple motion to approve an application will suffice, and a motion to deny must include an explanation of the factual and legal basis as to why one or more of the criteria have not been met.

Three Certificate of Need applications was considered under the regular CON agenda.

Phillip Earhart introduced the following, three (3) applications under consideration and with three (3) being approved.

1. go1 Home Health Care, L.L.C., Germantown (Shelby County), TN - CN2309-023

Request: For the establishment of a home health care organization and the initiation of home health services to be officed at 9842 Garden Place, Germantown (Shelby County), TN 38139. The service area will consist of Shelby, Fayette and Tipton Counties. The applicant is owned by 901 Home Health Care LLC. Estimated project cost: \$40,932.

Speaking on behalf of the applicant was Graham Baker.

OPPOSITION: Baptist Trinity Home Care & Hospice.

Speaking on behalf of the opposition was Kim Looney, Val Kelley, and Travis Swearingen.

Ms. Sweitzer moved for approval with Mr. Wainner providing the second.

Four members voted to approve the application—Sweitzer, Grandy, Jerman, and Wainner. Three members voted to deny the application –Brown, Pinkney, and Chinn. The motion CARRIED [4-3-0].

2. Premier Radiology - Lebanon, Lebanon (Wilson County), TN - CN2309-021

Request: For the establishment of an Outpatient Diagnostic Center (ODC) and the initiation of Magnetic Resonance Imaging services ("MRI") at 101 Physicians Way, Suite 111, Lebanon (Wilson County), TN 37090. The service area will consist of DeKalb, Macon, Putnam, Smith, Trousdale, and Wilson Counties. The applicant is owned by Middle Tennessee Imaging, LLC, dba Premier Radiology, LLC, and will be managed by PhyData, LLC. Estimated project cost: \$1,529,500.

Speaking on behalf of the applicant was Warren Gooch.

Mr. Pinkney moved for approval with Mr. Wainner providing the second.

Six members voted to approve the application— Sweitzer, Grandy, Jerman, and Wainner. Pinkney, and Chinn. The motion CARRIED [6-o-o].

LIMITATION: Limited to Magnetic Resonance Imaging (MRI) Services

3. Caris Healthcare, L.P., Knoxville (Knox County), TN - CN2310-025

Request: For the expansion and initiation of hospice services in Hancock County. Caris Healthcare's existing hospice license #611 includes the counties of Anderson, Blount, Campbell, Claiborne, Cocke, Grainger, Hamblen, Jefferson, Knox, Loudon, McMinn, Monroe, Roane, Sevier, and Union. The parent office is located at 10651 Coward Mill Road, Suite B, Knoxville (Knox County) TN, 37931. The service area will consist of Hancock County. The applicant is owned by Caris Healthcare L.P. Estimated project cost: \$8,000.

Speaking on behalf of the applicant was Travis Swearingen.

Mr. Pinkney moved for approval with Mr. Grandy providing the second.

Six members voted to approve the application—Sweitzer, Grandy, Jerman, Brown, Pinkney, and Chinn. The motion CARRIED [6-0-0].

CONDITION: The applicant must provide documentation that it is fully accredited by a third-party accrediting organization for hospice services, within 2 years of implementation of the CON.

The following application was deferred to January 2024

1. Premier Radiology - Mt. Juliet, Mt. Juliet (Wilson County), TN - CN2310-024

Request: For the addition of a second MRI unit to its existing outpatient diagnostic center located at 5002 Crossings Boulevard, Suite 140, Mount Juliet, (Wilson County) TN, 37122. The service area will consist of Davidson and Wilson Counties. The applicant is owned by Middle Tennessee Imaging, LLC, dba Premier Radiology and will be managed by Phydata, LLC. Estimated project cost: \$1,364,437.
