### Goals & Objectives

- Improve the physical, cognitive, and emotional functioning of Alzheimer's/dementia patients—thereby addressing "Improve quality of life and care of residents through personcentered care"
- Reduce the number and frequency of uptake of antipsychotic medications prescribed for patients pre-, during, and at end of grant period—thereby addressing "Reduction of unnecessary antipsychotic medication use among nursing home residents"
- Assess nursing staff and nursing students' attitudes pre- and post-intervention of Music & Memory to assess the focus area "Implementation of culture change initiatives that go beyond regulatory requirements to improve quality of care and life"


