## MINUTES BOARD FOR LICENSING HEALTH CARE FACILITIES EMERGENCY CALLED TELEPHONIC BOARD MEETING APRIL 1, 2020

The Board for Licensing Health Care Facilities Emergency Called Telephonic Board Meeting began on April 1, 2020. Dr. René Saunders, chair, called the meeting to order.

The first item for discussion was Dialyze Direct and the emergency issuance of an End Stage Renal Dialysis license. Mr. Paull was the representative of the facility but was not available on the phone at the time of the discussion. Ann Reed gave Board members details of the request. She spoke to the internal discussion with staff and OGC. Dialyze Direct had sent plans to the Plans Review section resulting in 22 review comments to the facility. Plans Review is still awaiting a response. Mr. Shulman asked if the review comments needed to be answered before approving the license. Ms. Reed stated that the Board could approve the license with the condition of answering the 22 review comments on the project. Caroline Tippens stated that the Board could grant a temporary license with conditions until the October 7, 2020 Board meeting. If the review comments aren't addressed the board will revisit the subject. Mr. Shulman made a motion to approve the licensure of Dialyze Direct as an End Stage Renal Dialysis Clinic conditioned upon submission of response to Plans Review comments by the October 7, 2020 Board meeting in light of the COVID-19 pandemic; Mr. Boyd seconded.

Dan Elrod submitted language to amend rule referenced in Board Policy #82 on temporary structures for Hospitals. The language was as follows to include further definition of temporary structure to include other space in the hospital that does not meet FGI guidelines and the use of space outside a hospital such as a nursing home, rehab facility, or hotel. Ms. Reed requested that facilities notify the Department if they chose to operate under the policy. Mr. Parisher, Facilities Construction Director, informed the Board that surveyors will monitor those facilities. **Mr. Shulman made a motion to amend Board Policy #82 with language submitted; Dr. Robbins seconded.**

practitioners and/or physician assistants to fill the role. There was much discussion on these requests especially given the scope of practice of physicians and advanced practice nurses. A motion was made by Mr. Shulman to approve, but the motion died due to the failure to secure a second.

Home Health Agency rule 1200-08-26-.06(7)(c) regarding supervisory visit by registered nurse to patient's place of residence at least monthly was requested to be waived to allow for alternative means to conduct the supervisory visits. Discussion ensued regarding the CARES Act which was approved on the federal level and the implications of this Act for the states. The Board members expressed concern over the previous discussion of home health agency rule 1200-28-26-.05(2) & (4) and 1200-08-26-.05(8) and the failure for the motion to move forward. Mr. Mynatt made a motion to suspend the current discussion of the home health agency rule and IG development regarding supervisory visits and to move back to the home health agency rule and IG regarding allowance of nurse practitioners and physician assistants to fill the role of a physician; seconded by Mr. Shulman.

Dr. Robbins made an amendment to the motion to prove competency; Vincent Davis, Executive Director of the Office of Health Care Facilities stated that was outside the CMS waiver. Dr. Robbins withdrew her amendment.
