# B. <u>BAPTIST MEMORIAL-MEMPHIS SKILLED NURSING FACILITY,</u> <u>MEMPHIS (NH #352)</u>

This thirty-five (35) bed skilled nursing unit at Baptist Memorial-Memphis Skilled Nursing Facility, Memphis is requesting an eighth extension for their license to remain on inactive status for an additional twelve (12) months thru February 2022. Baptist Memorial is actively pursuing plans for future use of the skilled nursing beds. Discussions have occurred with experience providers of long-term care about combining the 35-bed unit with the 18 skilled nursing beds licensed as Baptist Skilled Rehabilitation Unit-Germantown #391, and relocating the combined units to a new site. However, this has been significantly impaired by the public health crisis related to COVID-19 pandemic. Baptist Memorial-Memphis was granted an inactive status waiver on February 7, 2013 for twelve (12) months; an extension inactive status waiver was granted on January 23, 2014 for twelve (12) months; a second extension inactive status waiver on January 15, 2015 for additional twelve (12) months; a third extension inactive status waiver was granted on January 14, 2016 for additional twelve (12) months; a fourth extension for inactive status wavier was granted on February 8, 2017 was granted for twelve (12) months; a fifth extension for inactive status was granted on February 7, 2018 for additional twelve (12) months; a sixth extension for inactive status was granted on February 5, 2019 for additional twelve (12) months; and a seventh extension waiver for inactive status waiver on February 5, 2020 for additional twelve (12) months which will expire on February 5, 2021.

# C. <u>BAPTIST SKILLED REHABILITATION UNIT-GERMANTOWN</u> <u>SKILLED NURSING FACILITY, GERMANTOWN (NH #391)</u>

This eighteen (18) bed skilled nursing unit at Baptist Skilled Rehabilitation Unit-Germantown, is requesting a sixth extension for their license to remain on inactive status for an additional twelve (12) months thru February 2022. Discussions have occurred with experience providers of long-term care about combining the 18-bed unit with the 35 skilled nursing beds licensed as Baptist Memorial Hospital-Memphis #352, and relocating the combined units to a new site. However, this has been significantly impaired by the public health crisis related to COVID-19 Baptist Skilled Rehabilitation Unit-Germantown was granted an pandemic. inactive status waiver on January 21, 2015 for twelve (12) months; an extension inactive status waiver was granted January 14, 2016 for twelve (12) months; a second extension inactive status waiver was granted February 8, 2017 for twelve (12) months; a third extension inactive status waiver was granted February 7, 2018 for twelve (12) months; and a fourth extension for their license was granted February 5, 2019 for twelve (12) additional months; a fifth extension for their license to remain on inactive was granted on February 5, 2020 which will expire on February 5, 2021.

This forty-four (44) bed nursing home is requesting a third extension waiver for their license to remain on inactive status for an additional one (1) year. Signature HealthCare. Signature HealthCARE continues to search for viable options to reactivate the licensed facility and beds. No such option has presented itself to this point in time, and additional time of inactive status is needed to identify options for the future use of the facility, either through reopening, sale, or relocation. Hospice of Chattanooga Walker Road, Chattanooga, a residential hospice facility is requesting an extension waiver for inactive status for an additional one (1) year. Hospice of Chattanooga was in the process of planning a new residential hospice facility, either on the current site or on another site in Chattanooga. The circumstances created by the pandemic created an extremely difficult situation and one in which undertaking such a major project became problematic. # G. <u>LVC OUTPATIENT SURGERY CENTER, GOODLETTSVILLE (ASTC</u> <u>#149)</u>

LVC Outpatient Surgery Center, Goodlettsville is requesting to place their license on inactive status pending completion of the sale. Nashville TN Ophthalmology ASC, LLC, the owner, and primary operator of LVC Outpatient Surgery Center who has 51% of the ownership is in negotiations to sell the 51% interest. This sale is expected to occur prior to March 31, 2021. Given the structure of the transaction, the transfer will be upstream of the Center Entity, and the tax identification number and identity

of the license holder will not change. This facility will be able to resume normal operations within 2 to 4 weeks from the completion of the sale and firewall improvements which was asked in the last survey.

# H. <u>SENIOR SAINTS' HOME, CHATTANOOGA (RHA #84)</u>

This Residential Home for the Aged (RHA) facility is requesting a fourth extension waiver for their license to remain on inactive status for an additional twelve (12) months. The delay in completing the required remodeling has been due to COVID-19 and financial constraints, with minimal progress made in the past year. Senior Saints' Home is optimistic that the project should be completed during the next twelve (12) months. Senior Saints' Home was granted inactive status on September 7, 2016 for one (1) year; at the October 4, 2017 board meeting an representative for the facility was not present so the Board forwarded the inactive status extension request to the February 7, 2018 Board meeting where an inactive status extension waiver was granted for an additional one (1) year; a second inactive status extension was granted on February 5, 2020 for an additional one (1) year which will expire on February 5, 2021.

St. Jude Children's Research Hospital, Memphis is requesting an extension waiver of their expansion of services provided at their temporary COVID-19 locations through December 31, 2021. As the pandemic continues to affect our communities this extension will also cover the next flu season as well. St Jude Children's Research Hospital was granted this waiver on February 5, 2020 which will expire February 2021.

# B. <u>VANDERBILT UNIVERSITY MEDICAL CENTER, NASHVILLE (HOSP</u> <u>#27)</u>

Vanderbilt University Medical Center (VUMC), Nashville is requesting that the Board for Licensing Health Care Facilities to waive certain of its rules pursuant to T.C.A. §68-11-209(b), and otherwise interpret its rules, so VUMC may implement its federally approved hospital at home program. At its meeting on December 17, 2020, the Board adopted an interpretation of Executive Order #68 as suspending any hospital licensing rules that prohibit or impede a hospital from implementing an Acute Hospital Care at Home (HHC) program approved by the Centers of Medicare & Medicare Services (CMS) under its waiver process. This suspension of hospital licensing rules will expire when Executive Order #68 expires.

VUMC has applied for and believes it will receive approval from CMS to implement the HHC program. VUMC needs the Board waivers even if the CMS HHC program ends at the end of the public health emergency. The waivers would enable VUMC to continue its acute hospital at home care to non-Medicare patients after the public health emergency ends. Such waivers would avoid disruption in patient care in the event the federally-declared public health emergency extends beyond the time that Tennessee Executive Order #68 is in effect.

# C. <u>REGIONAL ONE HEALTH, MEMPHIS (HOSP #110)</u>

The Elvis Presley Trauma Center (EPTC) at Regional One Health is requesting a waiver of the state trauma center rule requiring cardiopulmonary bypass for Level I centers according to Trauma Rules 1200-08-12-.04(2)(c-1). While bypass was required to treat many injuries in the past (aortic transection), new modern methods including endovascular repair with stent grafting have now replaced open repair and bypass is no longer required. Patients with cardiac injuries that survive to hospital evaluation are repaired without bypass.

The current edition of the American College of Surgeons Committee of Trauma (ACSCOT) Resources for the Optimal Care of the Injured Patient has recognized that in Level I and Level II trauma centers, if cardiopulmonary bypass equipment is not immediately available, a contingency plan including immediate transfer to an appropriate center and 100 percent performance improvement review of all patients transferred, must be in place (CD 11-22).

Regional One Health maintains a transfer agreement with Methodist University Hospital, Memphis and is actively advocating through the Trauma Care Advisory Council that the Tennessee rules mirror ACS requirements. Regional One passed the designation visit for our Level 1 Trauma Center status with no deficiencies. Requiring cardiac bypass would put an unnecessary burden on the institution without benefit of improved care.

#### Regional One Health, Memphis (Hosp #110)

The Elvis Presley Trauma Center (EPTC) at Regional One Health is requesting a waiver of the state trauma center rule requiring cardiopulmonary bypass for Level I centers according to Trauma Rules 1200-08-12-.04(2)(c-1). While bypass was required to treat many injuries in the past (aortic transection), new modern methods including endovascular repair with stent grafting have now replaced open repair and bypass is no longer required. Patients with cardiac injuries that survive to hospital evaluation are repaired without bypass. The current edition of the American College of Surgeons Committee of Trauma (ACSCOT) Resources for the Optimal Care of the Injured Patient has recognized that in Level I and Level II trauma centers, if cardiopulmonary bypass equipment is not immediately available, a contingency plan including immediate transfer to an appropriate center and 100 percent performance improvement review of all patients transferred, must be in place (CD 11-22). Regional One Health maintains a transfer agreement with Methodist University Hospital, Memphis, and is actively advocating through the Trauma Care Advisory Council (TCAC) that the Tennessee rules mirror ACS requirements. Regional One passed the designation visit for our Level 1 Trauma Center status with no deficiencies. Requiring cardiac bypass would put an unnecessary burden on the institution without benefit of improved care. Dr. Croce and Dr. Kerwin were the representatives for this facility. Ms. Hughes Toombs presented as legal counsel for TCAC. She stated that she is in support of the waiver and that TCAC will need to make changes in Trauma rules to remove regulation and align with American College of Trauma Surgeon's standards. Ms. Tippens stated that rule revisions take up to 18 months to be finalized but the Board can develop an IG until the rules and regulations are updated. #### NURSE AIDE REPORT-

Ronda Webb Stewart, Assistant Director of HCF presented the Nurse Aide report. As of February 1, 2021 there were 34, 106 active nurse aides, 2,712 persons on the abuse registry, 319 approved training programs and 15 nurse aide certifications were revoked in 2020.

#### OFFICE OF GENERAL COUNSEL REPORT-

Caroline Tippens, Senior Associate General Counsel, presented the OGC report. Ms. Tippens stated there were 7 open cases in OGC. She also gave updates to the Board regarding the Assisted Care Living Facilities, Personal Support Services, and Hospitals rule packets being in internal review as well as the central service technicians, abortion, and testing for ACLF administrators. She also stated that the BENHA held a rulemaking hearing in March 2020 to adopt HSE credential and temporary licensing procedures for NHA are now pending.

#### OFFICE OF HEALTH CARE FACILITIES REPORT-

Vincent Davis, Director of Health Care Facilities presented the OHCF report. He stated that there is a suspension of surveys unless public health warrants i.e. initial and some complaints. There has been 1,805 Immediate Jeopardy complaints received, 1,093 infection focused surveys and 190 complaint surveys are still outstanding.
