SB503/HB768 Requires conducting of supplemental voter registration at high schools in the fall and

spring.

Sponsors: Sen. Akbari, Raumesh, Rep. Love Jr., Harold

Summary: Requires county election commissions conduct a supplemental registration at public and

private high schools once each fall and spring semester. Authorizes high schools to provide opportunities for students to register to vote online at times other than the supplemental

registrations.

SB655/HB1185 Juvenile Justice Stop Solitary Confinement Act.

Sponsors: Sen. Robinson, Katrina, Rep. Chism, Jesse

Summary: Declares that no juvenile detention facility shall place a minor offender in solitary

confinement unless solitary is used as a last means once all other less restrictive options have been exhausted or they are considered to be a serious security risk. Establishes that if a minor is placed into solitary, its will be no more than seven days, at a maximum of twenty-two hours per day. Requires a weekly report of each juvenile detention facility participating in

solitary confinement programs.

SB1340/HB1498 Inpatient treatment for certain persons being released from custody of corrections

facility.

Summary: Permits a court to commit a person scheduled to be released from a correctional facility to

the custody of the commissioner of mental health and substance abuse services for inpatient

treatment based on clear and convincing evidence that the person poses a substantial

likelihood of serious harm if released from custody. Broadly captioned.

SB18/HB285 Extends the statutes of limitation for certain sexual offenses committed against

children.

Summary: Extends the statutes of limitation for certain sexual offenses committed against children,

including rape of a child and aggravated rape of a child, when the crime was not reported to

law enforcement within three years of the offense.

SB24/HB17 Use of force by a minor who is victim of a sexual offense.

Sponsors: Sen. Gilmore, Brenda, Rep. Lamar, London

Summary: Gives the presumption that a minor who is the victim of a sexual offense and used force

against the offender had a reasonable belief that the force is immediately necessary to avoid

imminent death or serious bodily injury.

SB69/HB310 Release eligibility for minor who commits first degree murder.

Summary: Reduces from 51 years to 25 years the time required to serve before a minor who committed

first degree murder can become release eligible. This will affect said crime offenses

committed on or after July 1, 2019.

SB169/HB309 Statute of limitations on child sexual abuse crimes.

Summary: Eliminates he civil statute of limitations on child sexual abuse, while eliminating and

extending the statute of limitations on certain child sexual abuse crimes including rape,

promotion of prostitution, and sexual battery among other crimes.

SB258/HB260 Offense of reckless endangerment.

Summary: Expands the offense of reckless endangerment to include a person's reckless failure to render

inoperable or safely secure or lock a firearm and ammunition for the firearm, resulting in a child under 13 years of age gaining possession of the firearm and resulting in bodily injury or

death of the child or another person.

SB280/HB764 Increase age restrictions for tobacco and vapor-related products.

Summary: Increases age restrictions for tobacco and vapor-related products from 18 years of age to 21

years of age.

SB290/HB283 Increases the punishment for a conviction of aggravated rape of a child.

Summary: Increases the punishment for a conviction of aggravated rape of a child to life in prison

without the possibility of parole. Current law specifies that aggravated rape of a child is a Class A felony with the punishment for conviction as being sentenced to 15 to 60 years in

prison and a fine of up to \$50,000.

SB301/HB1456 Prohibits smoking and vaping in cars when a child in a safety seat is present.

Summary: Prohibits smoking and vaping in a motor vehicle when a child who is secured in a child

safety seat or required to be secured in a child safety seat is present in the vehicle.

SB353/HB321 Establishes an education training curriculum for law enforcement officers on diversity.

Summary: Establishes a education training curriculum and certificate of compliance for law

enforcement officers on diversity. Requires law enforcement to complete specified training

by July 1, 2021 or within six months of the officer's date of employment.

SB368/HB286 Statute of limitations - sexual offenses against children.

Summary: Deletes the statute of limitations for prosecution of certain Class A or Class B felony sexual

offenses committed against a child on or after July 1, 2019. Also deletes a provision that sets a lower statute of limitations for aggravated rape, rape of a child, rape, and aggravated rape of a child if notice of the offense is not given to law enforcement within three years of the

offense.

SB425/HB407 Residential, work, and treatment restrictions on sexual offenders whose victims are

minors.

Summary: Increases the prohibited distance from a school, child care facility, public park, recreation

center, or former victim's residence that a violent sexual offender can knowingly establish a

residence from 1,000 feet to 2,000 feet. Adds restriction that if the offender has been

convicted of a sexual offense or violent sexual offense where the victim was a child under 12

years of age, then the offender may not conduct an overnight visit at a residence in which a

minor resides or is present.

SB472/HB677 Reporting of person judicially committed for mental illness to determine eligibility to

purchase firearm.

Summary: Requires clerks to report the race, sex, and social security number of a person judicially

committed for mental illness to the FBI-NCIS index and department of safety to determine eligibility for person to purchase firearms. Requires such information to be confidential.

SB487/HB574 Reporting sexual abuse of a minor.

Summary: Changes the age that triggers the requirement that a physician report suspected sexual abuse

of a minor who is seeking an abortion from under 13 years of age to under 18 years of age.

SB577/HB193 Expunction of multiple convictions resulting from being a victim of human trafficking.

Summary: Allows for a petitioner who has multiple, nonviolent convictions resulting from being a

victim of human trafficking to be expunged by the court if deemed to be in the best interest

of justice. If denied, there shall be no petition filed for at least two years.

SB584/HB622 Requires notice of juvenile sexual offender requirements to charged children.

Summary: Requires that a child who is charged with a delinquent act that could qualify the child as a

violent juvenile sexual offender must be given notice of the violent juvenile sexual offender registration requirements at least 48 hours in advance of a hearing on whether the child

committed such act.

SB597/HB972 Communicating a threat of public harm.

Sponsors: Sen. Lundberg, Jon, Rep. Littleton, Mary

Summary: Creates the Class C felony offense of communicating a threat of public harm. Authorizes

juvenile detention for juveniles communicating a threat of public harm.

House Status: 02/11/19 - Referred to House Criminal Justice Subcommittee.

SB659/HB1168 Illegal use of narcotics while pregnant.

Sponsors: Sen. Bowling, Janice, Rep. Weaver, Terri

Summary: Authorizes assault prosecution for illegal use of a narcotic drug while pregnant if the child is

born addicted to or harmed by the narcotic drug. Provides addiction recovery program enrollment while pregnant and successful completion of the program as an affirmative

defense.

SB677/HB881 Drug Treatment Instead of Incarceration Act.

Sponsors: Sen. Gilmore, Brenda, Rep. Dixie, Vincent

Summary: Declares that the court will direct that a clinical assessment is performed of all persons

charged with a nonviolent drug offense, with their consent. Establishes that first-time offenders will be ordered to complete a rehabilitative drug treatment program and that the offender may be prosecuted to an increased extent if a multiple time offender. Declares that prosecution of a felony or nonviolent crime will move forward in event of failure of the rehabilitation course. Creates the Substance Abuse Treatment Trust Fund to administer the

provisions of the act along with a study of the effectiveness of these programs.

SB738/HB1419 Raises minimum age to purchase tobacco or vape products.

Summary: Increases the minimum age from 18 to 21 to purchase any tobacco or vapor products. Creates

a Class C misdemeanor offense of selling or distributing any flavored electronic cigarettes. Creates a rebuttable presumption that an electronic cigarette is flavored if a manufacturer or any of the manufacturer's agents or employees has made a statement or claim directed to consumers or to the public that the electronic cigarette has or produces a characterizing flavor, including, but not limited to, text, color, or images on the product's labeling or packaging that are used to explicitly or implicitly communicate that the electronic cigarette has a characterizing flavor. Increases the tax rate on cigarettes by 1.25 cents per cigarette.

SB813/HB801 Leaving a firearm or firearm ammunition unattended.

Summary: Creates a Class A misdemeanor offense of leaving a firearm or firearm ammunition

unattended with a minor in a motor vehicle or boat, if the firearm is not securely locked

away.

SB842/HB876 Parole eligibility - juveniles.

Sponsors: Sen. Akbari, Raumesh, Rep. White, Mark

Summary: Declares that if a person was sentenced when less than 18 years of age, the first eligibility for

parole will occur after 30 years of service if the sentence was over 30 years. Authorizes parolee eligibility after 20 years on the conditions of a HiSET(R) credential, unless a high school diploma has been obtained, one year of a job program, has positive habits and behavior, compiled with rehab services, and proved good character. Prohibits sentencing

persons to life without parole for crimes committed when a juvenile.

SB849/HB1459 Raises age to access or use tobacco and vape products.

Summary: Raises the age to access or use tobacco and vapor products from 18 to 21 years of age.

SB954/HB1035 Statutes of limitation for actions based on child sexual abuse.

Sponsors: Sen. Yarbro, Jeff, Rep. Shaw, Johnny

Summary: Extends the statute of limitations for civil actions based on child sexual abuse to five years

from discovery of the abuse.

SB985/HB1449 Community-based sentencing alternatives for primary caregivers.

Sponsors: Sen. Gilmore, Brenda, Rep. Camper, Karen

Summary: Declares that, notwithstanding any law to the contrary, if a person was convicted of a

nonviolent offense and is the primary caretaker of a dependent child, the court may impose an individually assessed sentenced without imprisonment, focused on parent-child unity and

support. Establishes conditions that may be followed in the ruling including anger

management courses, drug and alcohol treatment, and financial literacy courses. Specifies that a person serving an individually assessed sentence may be required to appear in court to

review their progress of the program.

SB1124/HB1455 First degree murder sentencing if defendant had severe mental illness.

Summary: Prohibits a court from sentencing a defendant convicted of first degree murder to death if the

defendant proves by a preponderance of the evidence that, at the time of the offense, the defendant had a severe mental illness. Defines "severe mental illness" to mean symptoms of psychosis shown by hallucinations, extremely disorganized thinking, or other significant disruptions of consciousness, memory, and perception that are not attributable solely to

repeated criminal conduct or the acute effects of the intentional use of alcohol or other drugs and a documented medical history of one or more of the following mental disorders: schizophrenia; schizoaffective disorder; bipolar disorder with psychosis; major depressive

disorder with psychosis; or delusional disorder.

SB1131/HB140 Extends statute of limitations on certain child sexual assault cases.

law enforcement within three years of the occurrence.

SB1134/HB838 Violations of TN Sexual Offender and Violent Sexual Offender Registration,

Verification and Tracking Act.

Summary: Adds conviction of a new sexual offense as violation of the Tennessee Sexual Offender and

Violent Sexual Offender Registration, Verification and Tracking Act of 2004. Broadly

captioned.

Increases the penalty for intentional reporting failures regarding child abuse or child sexual

abuse.

Amendment Senate Judiciary Committee amendment 1 (004426) changes 30 years to 15 years for civil

Summary: actions.

possession of a firearm.

SB1326/HB1320 School notification of certain adjudicated delinquent offenses.

Summary: Adds that all offenses listed are situations where the court must notify the child's school if

there is delinquent adjudication. Establishes the parents, guardians, or legal custodians, including the department of children's services acting in any capacity must provide notification if a student has committed certain offenses in this state or another state.

SB1402/HB754 Firearm prohibitions for persons suffering from mental illness.

possessing a firearm.

SB50/HB60 Early learning programs.

Sponsors: Sen. Gresham, Dolores, Rep. Dunn, Bill

Summary: Requires the department of education to create a three-year early learning pilot program, to

begin in the 2019-2020 school year, to identify early learning programs or models that provide opportunities for quality early childhood education and improvement in student outcomes. Requires the pilot program to be funded through a system of competitive grants utilizing voluntary pre-kindergarten funding. Specifies that grants are to be awarded by the department of education to no more than five LEAs that create a program as approved by the department that implements an early learning program to serve economically disadvantaged

students from birth through the third grade, in lieu of the LEA operating a voluntary

prekindergarten program.

SB58/HB94 Tennessee Outdoor Education and Recreation Grant Program.

Summary: Creates the Tennessee Outdoor Education and Recreation Grant Program, which provides

opportunities for public agencies, private NGOs, school programs and community-based programs focused on environmental, agricultural, or other natural resource-based education

and recreation programs to receive grants. Specifies that funds for the grant will be

appropriated by the general assembly and will be disbursed to the commissioner of education

to be expended for program purposes.

SB62/HB499 Education of students incarcerated in juvenile detention centers.

students incarcerated in detention centers for a minimum of four hours each instructional

day.

SB64/HB402 Participation in adverse childhood experiences (ACEs) training.

Sponsors: Sen. Robinson, Katrina, Rep. Staples, Rick

Summary: Directs each board of education to require adverse childhood experiences (ACEs) training

for all K-12 teachers, principals, and assistant principals employed by the Local Education Agency (LEA). Requires ACE training on an annual basis before the first day of instruction. Allows for the policy to either adopt the department of education ACE training guidelines or

for each LEA to adopt their own ACE training program.

SB170/HB405 Requires an adverse childhood experiences (ACEs) assessment before suspending or

expelling a child.

Sponsors: Sen. Robinson, Katrina, Rep. Love Jr., Harold

Summary: Requires each board of education to adopt a policy where an adverse childhood experiences

(ACEs) assessment must be done before expelling, suspending, assigning in-school

suspension, or ordering a student to attend another school. Establishes reports of suspension and expulsion must include and consider ACE assessments. The LEA is required to conduct an ACE assessment when considering disciplinary action if one has not been made within

one calendar year.

SB270/HB210 Appropriations for an LEA with prekindergarten children with disabilities.

Sponsors: Sen. Kelsey, Brian, Rep. Leatherwood, Tom

Summary: Establishes that prekindergarten programs operated by an LEA for children with disabilities

Clarifies that special classes, separate schooling, or other removals of a child with a disability from the regular educational environment must occur only when the student's IEP determines that the nature of the child's disability is such that education in a regular classroom setting with the use of supplementary aids and services cannot be achieved. Requires the department of education to enforce the IDEA and the state's special education laws. Requires the state board of education, in consultation with the department of education, to take necessary action to: (1) adopt standards for teachers and other personnel providing instruction or educational services to children with disabilities; (2) adopt the evaluation procedures and eligibility criteria for children with disabilities; and (3) cooperate with other state agencies, organizations, and institutions that are concerned with the health, education, and welfare of children with disabilities. Allows LEAs to contract with other LEAs to provide services for children with disabilities. In such instances, clarifies that the LEA in which the child is enrolled shall continue to be responsible for ensuring that the child receives the special education and relates services in accordance with the IDEA. Requires agreements or contracts pursuant to this section to be in writing and specifies that such agreements may include the provision of special education and related services, payment of reasonable costs associated with the services, or other related costs. Allows a parent or legal guardian to request the LEA to conduct a full or individualized evaluation of the child to determine if the child has a disability and is eligible for special education services. Requires the identification, location, and evaluation of children with disabilities to be conducted in accordance with the IDEA, the state's special education laws, and the state board of education's rules. Revises language regarding denial of BEP funding for noncompliance with the special education statutes. Make various other changes regarding special education. (22 pp.)

Amendment Summary:

Senate Education Committee amendment 1 (004405) replaces and adds language to the original bill that clarifies the state's legislative intent pursuant to the delivery of special education services. Expands the definition of children with disabilities by listing additional qualifying impairments and disabilities. Adds to the definition of related services required to assist a child with a disability in order to benefit from special education. Establishes criteria for the evaluation of proposed patients and reporting to the court by physicians and certain mental health professionals. Prohibits the court from ordering assisted outpatient mental health treatment unless the examining physician or other professional that recommended the treatment testifies at the hearing. Requires the court to order inpatient care and treatment or make other dispositions authorized by law if, after hearing all relevant evidence, the court does not find that the proposed patient is in need of assisted outpatient mental health treatment. Specifies requirements for court regarding less restrictive alternative

treatment. (11 pp.)

transportation agent may seek reimbursement for the transportation services from the medical insurance of the transported, and if there is no medical insurance, to be reimbursed

from the department of mental health and substance abuse services.

Creates civil liability for an unlicensed person providing mental health psychotherapy services for

treatment of a mental health disorder.
