



RESOLUTION OF THE TENNESSEE PUBLIC CHARTER SCHOOL COMMISSION
REGARDING INVICTUS NASHVILLE CHARTER SCHOOL AMENDED APPLICATION APPEAL

Whereas, pursuant to T.C.A. § 49-13-101 et. seq., Invictus Nashville Charter School (“Invictus”) submitted an appeal on the denial of its amended charter school application by the Metro Nashville Public School Board of Education dated August 2, 2023 to the Tennessee Public Charter School Commission (“Commission”), which is charged with serving as an appellate authorizer beginning with the 2020-2021 school year, and;

Whereas, representatives of the sponsor of Invictus participated in a public hearing on September 11, 2023 to answer questions of the Commission staff and receive comment from members of the public in the proposed district, and;

Whereas, the Commission’s Charter Review Committee, conducted a capacity interview on September 13, 2023, at which time representatives of Invictus provided responses to questions from members of the Review Committee, and;

Whereas, the Commission, at a quarterly meeting on October 6, 2023, reviewed, discussed, and considered the full appeal record, review committee report, and Executive Director’s recommendation prior to voting on a decision;

Whereas, the Commission, determined the following findings of fact:

1. Invictus meets/exceeds standard for academic plan design and capacity
2. Invictus meets/exceeds standard for operations plan and capacity
3. Invictus meets/exceeds standard for financial plan and capacity

Therefore, be it resolved by the Tennessee Public Charter School Commission that the amended application for Invictus Nashville Charter School is approved, pursuant to T.C.A. § 49-13-108(5)(C).

Commissioner Eddie Smith moved for approval of the Resolution.
