A 46 year old male employee was pinned between two semi trailers. A newly hired employee was operating the truck on the day of the incident while the victim, the trainer, was riding as a passenger. The employees traveled to Counce, TN to pick up their load for delivery. Upon entering the lot, the desired trailer was identified and the victim requested that the trainee back the semi tractor under the trailer. The trainee stated that he backed the semi tractor under the trailer and pulled the tractor forward to ensure the trailer king pin was inside the semi tractor's hitch, locked in place and secured. Once secured, the victim exited the semi tractor, walked around the front of the truck, down the driver's side of the truck and began hooking the trailer up to the semi tractor. The trainee stated that he looked into his driver's side mirror and observed the victim hook both air lines going from the semi tractor to the trailer in the glad hands by standing on the back portion of the truck. The victim climbed off the truck and began to raise the landing gear for the trailer. The trainee stated, at this point he left the drivers' seat and entered the sleeper area to retrieve some paperwork pertaining to this load. As the trainee was entering the sleeper area he stated he felt the truck began to roll. The trainee jumped back into the driver's seat and placed his foot onto the brake pedal of the semi tractor and turned the engine off. The trainee exited the cab area of the semi tractor and saw the victim was pinned between the trailers. The trainee observed a shuttle truck driver in the area so he ran to this driver and requested help. Emergency personnel were called on site. During interviews the trainee stated that the semi tractor was in neutral at the time it began to roll and the parking brake was not engaged. The victim passed away at the site.

Photo 2 of 3 – The circle denotes the area where the victim was crushed and measured approximately 4/12 to 5 inches between the two trailers.


