5 Struck by falling tree – Inspection #1133692

A **26 year old male** employee was fatally injured when he was struck by a falling tree. On the day of the incident, the owner and his two employees, that were also his step-sons, had been cutting storm damaged timber with chainsaws. One employee operated the grapple skidder moving the cut logs to the landing area while another cut the storm damaged timber. During the investigation it was determined, that the victim felled a red oak tree that became lodged against a poplar tree. According to the logging standard, once a tree becomes lodged, mechanical equipment should be used to remove the tree. However, the victim went to the base of the poplar tree to fell it with his chainsaw. As a result the poplar began to fall and the lodged red oak fell striking the employee. The employee was found unresponsive.
