First Savings Bank has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff on November 30, 2023. The total number of affected workers is four who work remotely in Tennessee. This company is located at 702 North Shore Drive, Suite 300, Jeffersonville, IN 47130. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on October 5, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
