Resolute Forest Products WARN # 202100026

Resolute Forest Products has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff effective February 12, 2022, or within 14 days of that date. This layoff is the result of the discontinuance of pulp and paper operations. The total number of affected workers is 350. This company is located at 5020 Highway

11 South, Calhoun, TN 37309. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on December 17, 2021.

The employees at the facility are represented by a collective bargaining agreement. The Southeast Local Workforce Development Area rapid response team, employed by Southeast Tennessee Development District, has been notified to coordinate services with the employer and affected employees. The Southeast Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
