Mose and Garrison Siskin Memorial Foundation Inc. d/b/a Siskin Children's Institute has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff on October 3, 2023. The total number of affected workers is 66. This company is located at 1101 Carter Street, Chattanooga, TN 37402, & 225 Lookout Street, Chattanooga, TN 37403. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on August 9, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Southeast Local Workforce Development Area rapid response team, employed by Southeast TN Development District, has been notified to coordinate services with the employer and affected employees. The Southeast Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
