ABM Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective October 4, 2020. ABM Inc. provided parking services for Hertz Car Rental. Hertz has canceled the contract with ABM Inc. effective 11:59 pm on October 4, 2020, resulting in this layoff. The total number of affected workers is 57. This company is located at 800 Hangar Lane, Nashville, TN 37214. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on September 28, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
