Alsco Linen & Uniform Rental Services Nashville has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective March 24, 2020. The total number of affected workers is 34. This company is located at 3101 Charlotte Ave., Nashville, TN 37209. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on March 30, 2030.

The employees at the facility are represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Mid-Cumberland HRAhas been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
