CKE Restaurants Holdings, Inc.has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a layoff that is expected to be temporary for some, and permanent for others. These layoffs are effective on April 6, 2020. The total number of affected workers is 95. This company is located at 6700 Tower Circle, Franklin, TN 37067. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 1, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Mid-

Cumberland HRA has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
