Castlerock Hospitality Employees LLC dba Bobby Hotel has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which, is effective March 13, 2020, with all layoffs completed by March 24, 2020. This layoff was originally intended to be temporary. The total number of affected workers is 95. This company is located at 230 4th Avenue North, Nashville, TN 37219. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on August 14, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The

Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
