FLSmith Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure which is effective August 18, 2020. The total number of affected workers is 113. This company is located at 3622 Bristol Hwy. Johnson City, TN 37601. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on June 22, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The North East Local Workforce Development Area rapid response team, employed by the Alliance for Business and Training has been notified to coordinate services with the employer and affected employees.

The North East Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
