Hard Rock Café Memphis has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective April 13, 2020. Layoffs will begin April 13, 2020 and continue through April 27, 2020. The total number of affected workers is 48. This company is located at 126 Beale Street, Memphis, TN 38103. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 23, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Greater Memphis Local Workforce Development Area rapid response team, employed by the Workforce Investment Network has been notified to coordinate services with the employer and affected employees. The Greater Memphis Local Workforce Development Board will be responsible for the oversight of the
