Holiday Inn Nashville Vanderbilt has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective April 3, 2020. Additional employees have a layoff date of 4/18/2020. The total number of affected workers for both layoff dates is 70. The employer indicates that certain employees will be laid off either temporarily or permanently on these two dates. This company is located at 2613 West End Avenue, Nashville, TN 37203. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 21, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle
