HRI Properties dba Holston House Nashville has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective June 4, 2020, with all layoffs completed by June 5, 2020. The company states that this layoff will "affect all employees or at least 23 employees". This permanent layoff notice follows a temporary layoff notice filed by the company on April 24, 2020, for 48 employees. This company is located at 118 7th Avenue North, Nashville, TN 37203. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on July 6, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle
