Johns Manville has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective May 21, 2020, through May 30, 2020. The company indicates this is the first curtailment of layoffs and further layoffs are possible. The total number of affected workers is 25. This company is located at 2235 Hwy. 411 North, Etowah, TN 37331. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 22, 2020.

The employees at the facility are represented by a collective bargaining agreement. The South East Local Workforce Development Area rapid response team, employed by the South East Tennessee Development District has been notified to coordinate services with the employer and affected employees. The South East Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
