Mrs. Grissom's Salads Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective June 21, 2020, with all separations being complete the first half of July. This layoff is necessitated by the recent decision of Dollar General ceasing a long-term relationship with the company. The total number of affected workers is 98. This company is located at 2500 Bransford Ave, Nashville, TN 37204. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 22, 2020.

The employees at the facility are represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials

has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
