OS Restaurant Services, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective March 15, 2020. The Company expects this change to be temporary and is hopeful that employees will be recalled to hours approximately equivalent to pre-pandemic hours. The total number of affected workers is 2,406. This company is headquartered at 2202 N. West Shore Blvd., 5th Floor, Tampa, Florida 33607. The company operates 37 locations in Tennessee, in the following counties; Anderson, Bradley, Davidson, Hamilton, Knox, Montgomery, Putnam, Rutherford, Sevier, Shelby, Sullivan, Sumner, Washington, Williamson, & Wilson. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 27, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The North East, South East, Upper Cumberland, Northern Middle, & Greater Memphis Local Workforce Development Areas rapid response teams, employed by the Alliance for Business & Training, East TN HRA, South East TN Development District, Workforce Essentials, & the Workforce Investment Network has been notified to coordinate services with the employer and affected employees. The North East, South East, Upper Cumberland, Northern Middle, & Greater Memphis Local Workforce Development Boards will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
