The total number of affected workers is 75. This company is located at 120 Spence Lane, Nashville, TN 37210. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on March 24, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Mid-Cumberland HRA has been notified to coordinate services with the employer and affected employees.
