PSA Airlines has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a layoff that is intended to be temporary. The layoff is effective October 1, 2020, with all layoffs completed by October 15, 2020. The total number of affected workers is 20. This layoff is in addition to WARN #202000325, which affected 103 workers. Total affected workers for both notices are 123. This company is located at 2055 Alcoa Highway, Alcoa, TN 37701. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on August 7, 2020.

The employees at the facility are represented by a collective bargaining agreement. The East Local Workforce Development Area rapid response team, employed by the East Tennessee Human Resource Agency has been notified to coordinate services with the employer and affected employees. The East Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker
