What is a Motor Vehicle Temporary Lien (MVTL)?

As of November 1, 2014 page 1 of 2

- **T.C.A. § 55-3-126(f)(1)**
- When a manufacturer's statement of origin or an existing certificate of title on a motor vehicle is unavailable, a first lienholder or the first lienholder's designee may file an application for motor vehicle temporary lien with the secretary of state. The filing fee for each application for motor vehicle temporary lien is ten dollars (\$10.00). The filing of an application for motor vehicle temporary lien shall constitute constructive notice of the lien against the motor vehicle as described to creditors of the owner, subsequent purchasers and encumbrancers, except liens as are by law dependent upon possession.

What is a Motor Vehicle Temporary Lien (MVTL)? page 2 of 2

- **A temporary recording of a lien on a motor vehicle prior to the issuance of the permanent certificate of title evidencing the lien.**
- **Perfection of the temporary lien occurs when the application and required fee is filed with the secretary of state's office.**

Coming Changes and Updates page 1 of 2

Effective November 2014

- Ability to file MVTL applications online. This will give the lienholder the ability to secure its interest in the vehicle before the vehicle leaves the dealership.

Coming Changes and Updates

(cont.) page 2 of 2

- Underlying notarized security agreements or bills of sale will no longer be required or accepted for secretary of state's office records.
- Payment vouchers will no longer be issued.
 - Existing vouchers will be accepted 6 months from the date of issuance.

- ✓ **Payment of the filing fee using an e-check, credit card, or debit card**
 - Total \$11.25; of which \$10.00 is the filing fee and \$1.25 convenience fee.
 - The **convenience fee** covers the cost incurred by the Secretary of State in offering the online filing services to our customers. It covers credit card fees and other transaction costs.





About Motor Vehicle Temporary Liens

The Motor Vehicle Temporary Lien Program began on July 1, 1998. This program establishes a procedure in the Office of the Secretary of State for recording a temporary lien on a motor vehicle prior to the issuance by the Department of Revenue of a permanent certificate of title evidencing that lien.

If a manufacturer's statement of origin or an existing certificate of title on a motor vehicle is unavailable, a first lienholder or his designee may file with the Division of Business Services an Application for Motor Vehicle Temporary Lien. The proper filing of such a document with the Division of Business Services constitutes constructive notice of the lien against the motor vehicle described therein to creditors of the owner, subsequent purchasers and encumbrances, except liens that are by law dependent on possession.

Constructive notice is effective from the time of the filing of the application. A temporary lien properly filed with the Division of Business Services automatically terminates after 180 days or upon being otherwise perfected, whichever occurs first. After 270 days, the temporary lien documents are purged from the filing system and destroyed.




